The main update from DCC this month is that we are on course to have broken even for the 2022/23 financial year which is a huge achievement given that we were facing a £40 million overspend this time last year if we took no action. It also puts us in a stronger position for this new financial year that we are now in.

The theme for the next two years is going to be modernisation with the new Chief Executive, Donna Manson, very firmly setting her sights on how we can make efficiencies that will <u>improve</u> DCC services and make the Council a more modern and dynamic organisation.

On local Highways matters, Parish Cllrs should have seen the email I sent from Mark James about the road past West Ash Farm. Safety defect repairs should have taken place now but we have put it forward for a full patching/resurfacing scheme. This will have to compete with all the other priorities but if we don't ask, we don't get, and Highways are at

least aware of the condition of the road and that it needs further treatment.
