FP53 Reports from outside bodies

a) To receive a report from Devon County Councillor, Cllr A Saywell.

- Huge pressure on Highways Network. Getting about 500 pothole reports a day at the moment. 2700 defects to repair across the county. Some of the workers are now out gritting so there is a backlog. Please be patient but keep reporting the potholes or any highways concerns.
- Overspend has gone down to £7,000,000. Still looking at trying to reduce this figure*

- Draft budgets set for next year. Adults and Highways will include increases in their budget.
- Donna Manson, new Chief Executive. Come from Scotland.
- Community Speed Watch Look at setting up as it does have teeth now. Needs to be community led training is delivered by the police. 3 is the minimum for a speed watch group.

b) To receive report from Torridge District Councillor, P Pennington.

- Same as previous.
- CT setting at the end of Jan.
- Almost certainly the council will vote for the max increase w/d triggering a referendum.
- Would like an update from Cllr Hunkin re: Playing Field Grant. Clerk said that she was awaiting a quotation so she can submit the application.
